*Nineteenth Century Legal Treatises* includes more than 15,000 British and American works from the world's leading libraries, with the majority of material acquired from the Harvard Law School Library. This unique collection encompasses a range of literature produced during this century for research into legal and general history, including casebooks, local practice manuals, books on legal form, works for lay readers, pamphlets, letters and speeches.

*Twentieth Century Legal Treatises* covers nearly every aspect of British and American law in the 20th century. Because access to materials in their original form has become increasingly difficult, the expansion of this collection is an important development to modern scholars. Materials for this publication have been acquired from the Harvard Law School Library, Yale Law School Library and the York (Canada) Law School Library.
