Guide to the arrangement of this book

This book has been arranged in order to allow the reader to find any entry rapidly and accurately.

Company entries are listed alphabetically within each country section; in addition three indexes are provided at the back of each directory.

The *alphabetical index to all companies* lists all companies having entries in each volume in alphabetical order irrespective of their main country of operation.

The *alphabetical index to companies within each country* lists companies by their country of operation. In both of these indexes companies with names such as A B Smith can be found listed as A B Smith and Smith, A B.

The *SIC (Standard Industrial Classification) business activity index* in each volume lists companies by their various business activities within their main country of operation. These SIC index categories are listed at the beginning of the business activities index.
